Grenada is a member of the Caribbean Community (CARICOM) and the Organization of Eastern Caribbean States, and is becoming a top choice of destination for high-net worth investors.



Grenada's Citizenship by Investment Program was reinstated in 2013. Grenadian citizenship affords visa-free travel to 114 destination, including Singapore, China, Hong Kong, the United Kingdom (even after Brexit) and EU. Grenadian citizens are entitled to enroll in the United States' E-2 visa program, allowing investors to reside and launch businesses in the US. Citizens remain US citizens as long as they renew their visas.

## BENEFITS



- Passport power rank is 33 globally
- Citizenship privileges can be extended to dependent children under twenty-five years of age and dependent parents over fifty-five years.
- Travel to Grenada during the application process is not required
- No physical residency requirements
- No income, wealth, or inheritance taxes
- Visa-free or visa-on-arrival travel to 144 destinations
- Eligibility to apply to the USA for a non-immigrant investor visa, due to the country's E-2 Investor Visa treaty
- Citizenship transferable to new spouses and future generations.
- The ability to include a spouse, children under 30, unmarried siblings aged 18 and over, parents, and grandparents of the main applicant and spouse of any age.
- No restrictions on dual citizenship in Grenada.
- No minimum stay required

## REQUIREMENTS

- Applicants must undergo a medical check
- Applicants must undergo security screening
- Proof of the source of invested funds
- A minimum age of 18 years

## PROCEDURES

---

Processing time

Once an application is submitted, the government should provide approval within 90 days. Thereafter, the qualifying investment is made and the citizenship documents are issued.

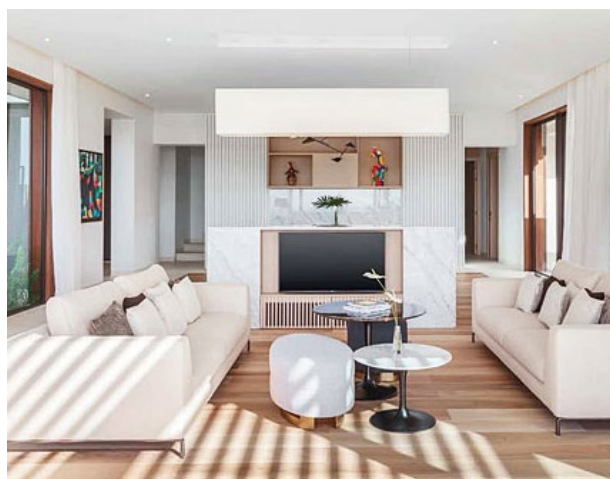
### Silversands hotel & villas
