- Applications are processed by a citizenship by investment unit, a dedicated government authority within the Ministry of Finance that is responsible for the management of the program.
- All required documents may be filed remotely
- Application processing takes approximately 3 months
- Visa-free or visa-on-arrival travel to more than 146 destinations
- Ability to include a spouse, children under 31, siblings under 18, and parents aged 56 and over, as well as to add dependents after citizenship has been granted to the main applicant

REQUIREMENTS

- Main applicant must be at least 18 years old
- Applicants must undergo a medical check
- Applicants must pass a due diligence background check along with their qualifying dependents over the age of 18.
- No criminal record

Processing time

The application process should take no longer than three months from the submission of the application to the issuance of the certificate of citizenship, assuming there are no areas of concern with the application.
